



Yelm COVID-19 Business Grant Report

September 3, 2020



The Yelm COVID-19 Business Grant was created by the General Government Committee, Mayor Foster and other city staff members in response to the growing need of the community after the effects this pandemic had on the City of Yelm. The grant was funded through the **\$274,050** the city received from the Coronavirus Aid, Relief and Economic Security (CARES) Act. The General Government Committee decided to allocate the funds in two ways that supported the community:



- (1) \$109,620 to the Yelm COVID-19 Business Grant, which was made available to all businesses inside the city limits of Yelm that could demonstrate economic hardship or loss of revenue due to COVID-19 and/or increased costs to comply with reopening.
- (2) \$27,405 to the Yelm Community Relief Fund, a program created by Mayor Foster, his wife Nicki, TOGETHER! and America's Credit Union, that provided some immediate relief to residents struggling financially during this pandemic.

Council unanimously approved the fund allocation during their council meeting on June 9th, 2020. In addition, council approved the purchase of 100 gallons of hand sanitizer to be used by local businesses in the hopes it would save them money as they reopened.

The grant application went live on the City of Yelm's website and social media accounts on June 12th, 2020. It was broadly promoted through announcements at public meetings, the Yelm Chamber of Commerce, our social media accounts and local newspapers. We immediately received a flood of applications and the General Government Committee along with the Finance Department worked tirelessly to process them and get businesses in compliance with our requirements if they were not already.

In order to qualify for the grant a business must: (1) have a physical location/office inside of city limits; (2) have a Yelm business account; (3) have an active Yelm General Business License or active Home Occupation License OR a non-profit organization serving the Yelm community located within Yelm city limits and; (4) report income generated inside Yelm and pay B&O taxes to the city. In total, 47 businesses received the Yelm COVID-19 Business Grant in the amount of up to \$2,500.
